Certificant Disciplinary Actions: Revocations, Suspensions, Probations and Letters of Reprimand

Last Effective Date: 5/1/2012

Revocation: A Certificant's certification has been revoked and that person is no longer certified. A revocation may be: 1) permanent, meaning that the person may not sit for a certification exam in the future; or 2) non-permanent, meaning that the person may sit for a certification exam again at some designated time in the future. The former Certificant **MAY NOT:** 1) advertise using their credential or any NCBTMB logo; 2) use their certificate in any other way to promote their practice; or 3) in any way hold themselves out to be certified by NCBTMB.

Suspension: A Certificant's certification has been suspended for a definite period of time and may be subject to meeting certain requirements before the suspension is lifted. During the suspension period, the Certificant **MAY NOT:** 1) advertise using their credential or any NCBTMB logo; 2) use their certificate in any other way to promote their practice; or 3) in any way hold themselves out to be certified by NCBTMB.

Probation: A Certificant has been placed on probation for a definite period of time and may be subject to meeting certain requirements before the probation is lifted. During the probationary period, the Certificant **MAY** continue to: 1) advertise using their credential or any NCBTMB logo; 2) use their certificate in any other way to promote their practice; or 3) in any way hold themselves out to be certified by NCBTMB.

Letter of Reprimand: A letter has been issued to a Certificant advising them that they are being reprimanded and that, should they be found to be in violation of the Code of Ethics and/or Standards of Practice in the future, the reprimand may be considered when determining the appropriate disciplinary action for those future violations. The Certificant **MAY** continue to: 1) advertise using their credential or any NCBTMB logo; 2) use their certificate in any other way to promote their practice; or 3) in any way hold themselves out to be certified by NCBTMB. (Note: Letters of Reprimand will appear on this report for approximately 90 days after the decision becomes final and then will be removed.)
