

# November Reviews

The charts below provide ongoing updates about applications that are currently in review -- for both initial and renewal candidates. The information includes the date an application was received, as well as its status (approved or denied) and the date a decision letter should be received. Applications are reviewed to determine if candidates meet the prerequisites outlined in the Approved Provider Application and include proper documentation. They are either approved or denied. If you do not receive a decision letter within 5 business days of the "You Will Receive Notification By" date, please e-mail [ce@ncbtmb.com](mailto:ce@ncbtmb.com).

**Approved** Approval status is granted for three (3) years. If you are an initial applicant, all courses you have taught (that fit NCBTMB guidelines for CE) that have been submitted by NCBTMB certificants will be retroactively applied toward CE credit. This retroactive credit extends to the last two years from the date of your approval.

**Denied** Denial status is issued to applicants who do not meet NCBTMB's definition of a provider of continuing education for the field of massage therapy/bodywork. Individuals or organizations may appeal a denial. To do so, they must send a letter of appeal that shows reasonable cause for reconsideration. The appeal letter must be received by NCBTMB within sixty (60) days of the applicant's receipt of a decision letter. Failure to respond within the time frame will result in forfeiture of the fee and require re-submission on the part of the applicant.
