Suspension is based on several factors including gravity and credibility of allegations and risk that a school poses to NCBTMB's educational or operational requirements. Based on subsequent review of the school and related findings, a school code may be reinstated or withdrawn.

Revocation: A final decision taken after a full review by NCBTMB which prevents a school's graduates from being made eligible for Certification with NCBTMB. Revocation is based on evidence compiled during an investigation that a school does not meet NCBTMB's operational or educational requirements.
