**Revocation:** An Approved Provider has been revoked and that Approved Provider's CE's are no longer accepted for NCBTMB recertification. A former Approved Provider MAY NOT: 1) advertise using their NCBTMB Approved Provider logo; 2) in any way hold themselves out to be an NCBTMB Approved Provider.

**Suspension:** An Approved Provider has been suspended and that Approved Provider's courses taught during the suspension period will not be accepted for NCBTMB recertification. During the suspension period the person or entity MAY NOT: 1) advertise using their NCBTMB Approved Provider logo; 2) in any way hold themselves out to be an NCBTMB Approved Provider during the suspension period.

**Probation:** An Approved Provider has been placed on probation for a defined period of time and may be subject to meeting certain requirements before the probation is lifted. During the probationary period the Approved Provider's courses taught during the probationary period will be accepted for NCBTMB recertification. During the probationary period the Approved Provider MAY: 1) advertise using their NCBTMB Approved Provider logo; 2) may hold themselves out to be an NCBTMB Approved Provider.
